PHASE 1: Historical Audit (Days 1-7)

Export Returns Report (Dec 15 - Today)

Date Completed: Total Returns:

Identify "Zombie Returns" (Delivered but pending)

Weight-check high-value items (\$100+)

PHASE 2: Filing Sprint (Days 8-14)

File Priority 1 claims (Dec 15-31)

File Priority 2 claims (Jan 1-15)

Record all case numbers & set reminders

PHASE 3: New System (Days 15-30)

Schedule Sunday morning audit habit

Calibrate weight scale & photo station

Initialize internal tracking spreadsheet

Daily 15-Minute Routine
